Performance horses need more electrolytes

Electrolytes are essential nutrients for the performance horse. Since horses lose large quantities of electrolytes in sweat, requirements increase with exercise intensity and sweat loss.

Electrolytes are a critical component of a performance horse's feeding program since they play an important role in maintaining osmotic pressure, fluid balance and nerve and muscle activity.

During exercise, sodium potassium and chloride are lost in large quantities through sweating. Loss of these electrolytes causes fatigue and muscle weakness and decreases the thirst response to dehydration.

It was vitally important that performance horses begin competition with optimal levels of fluids and electrolytes in their bodies and that these important nutrients are replaced throughout prolonged exercise.

Sweat loss

It is important to have some idea of the magnitude of electrolyte loss a horse incurs during exercise before a feeding program can be developed to replace these losses.

Because most electrolyte losses in the horse occur through sweating, one method of calculating electrolyte requirements can be based on different amounts of sweat loss. The Table contains the levels of sodium, chloride and potassium electrolytes required per day by a horse at rest and after exercising hard enough to lose 5, 10, 20 and 40 liters of sweat.

The amount of sweat loss will depend on a number of factors, such as the duration and intensity of exercise, temperature and humidity.

In general, horses exercising at a low intensity will lose between 5 liters and 10 liters of sweat per hour. During higher-intensity exercise, sweat loss levels reach as much as 15 liters per hour.

At the 1996 Olympic Games in Atlanta, Ga., horses lost an average of 18.4 kg of bodyweight during the speed and endurance phase of the three-day event, which translates into a sweat loss of around 15 liters.

Total daily electrolyte requirements (g/day) as a function of sweat loss

Sweat loss per day

Electrolyte	At rest	5 liters	10 liters	20 liters	40 liters
Sodium (Na+)	15-20	33	50	85	155
Chloride (Cl-)	27-33	55	83	139	251
Potassium (K+)	40-50	46	52	64	88

Electrolyte requirements

Unfortified hay and grain rations tend to be deficient in sodium and contain variable quantities of chloride. In contrast, most forage is high in potassium and, when fed in adequate quantities, will meet daily potassium requirements.

Sodium chloride (salt) offered as a free-choice block or top-dressed onto grain, along with adequate forage, will meet the electrolyte requirements of idle and lightly exercised horses.

However, if forage intake is restricted (less than 1% of bodyweight on a dry matter basis) and/or high sweat loss occurs as a result of hot summer weather and moderate to heavy work, then additional potassium supplementation may also be necessary.

Many commercial electrolytes contain sugar (dextrose) that is purported to improve electrolyte uptake in horses. Recent research at Kentucky Equine Research has demonstrated that this is not true.

Thoroughbreds were dosed with 92 g of electrolyte – 72 g of sodium chloride and 20 g of potassium chloride – either

alone, with 10 g of dextrose or with 100 g of dextrose.

The electrolyte mixes were dissolved in one liter of water and administered via nasogastric tube. A fourth treatment of liter of water with no added electrolytes served as a control.

Plasma sodium and osmolality were significantly elevated post-dosing in all three electrolyte treatments compared to the control, but dextrose did not affect the rate or duration of the increase. All electrolyte treatments increased voluntary water intake, which is important in performance horses.

A second trial using deuterium oxide-labeled water showed that the addition of dextrose did not affect the rate of water uptake from the digestive tract compared to a straight electrolyte mix.

An interesting alternative source of sodium for performance horses is Equishure, an encapsulated sodium bicarbonate designed to prevent hindgut acidosis in horses. The vegetable oil-based encapsulation agent prevents the rapid breakdown of the sodium bicarbonate in the small intestine, which allows it to survive into the large intestine, where it slowly dissolves over the course of 6-24 hours.

Digestion trials conducted at Kentucky Equine Research have shown that the sodium in this product is digested and absorbed as completely as sodium from sodium chloride, but it is absorbed more slowly, resulting in greater sodium retention.

Furosemide effects

In the U.S., 90% of Thoroughbreds and up to 70% of Standardbred racehorses are treated with furosemide (Lasix) before racing to prevent exercise-induced pulmonary hemorrhage.

Furosemide exerts a diuretic effect by reducing the reabsorption of sodium in the kidneys. The magnitude and duration of electrolyte loss following furosemide administration has not been previously measured in horses.

Kentucky Equine Research recently conducted a study to measure the effect of furosemide on 72-hour urinary and fecal excretion of calcium, phosphorus magnesium, sodium, potassium, chloride and sulfur in non-exercised Thoroughbred geldings.

Total fecal and urinary excretion was measured 72 hours before and 24 hours, 48 hours and 72 hours after a single dose of 0.5 mg of furosemide per kilogram of bodyweight.

Urinary sodium excretion increased 24 hours post-furosemide administration but returned to pretreatment levels between 48 hours and 72 hours post-treatment.

Calcium, potassium and chloride balances were negative at 72 hours post-treatment even though the horses received adequate dietary mineral levels. Urinary phosphorus and magnesium excretion was unaffected by treatment. Fecal excretion of all minerals was unaffected by treatment.

This study shows that furosemide administration has a profound and long-lasting effect on electrolyte balance in horses.

Longer-term studies are needed to assess the effect of chronic furosemide administration on calcium loss and skeletal soundness in horses.

Additional studies are also needed to develop electrolytes supplementation strategies to correct the electrolytes imbalances caused by furosemide administration in racehorses.

Conclusion

In summary, electrolytes are essential nutrients for the performance horse. Since horses lose large quantities of electrolytes in sweat, requirements increase with exercise intensity and sweat loss.

Adequate intakes of good-quality forage and free-choice salt will meet the electrolyte requirements of idle or lightly-exercised horses. Additional electrolyte supplementation, including potassium, may be necessary if forage intake is limited and sweat loss is moderate to heavy.

Racehorses treated with furosemide require potassium supplementation, even if they are receiving adequate forage.

Yvonne Kunz debuted in 1992 as Editor and Chief of the ATBA magazine. She was tucked away in her small office, in the back of the Rizzonico's Vet Clinic across the street from Turf Paradise. There she produced the Breeders magazine and assisted with the "Best Little Sale In The West" for two years.

Due to the resignation of Executive Director, midterm, and her keen eye to detail, Yvonne was asked to step in and take the reigns of the director's position. She turned the board down for the position, but agreed to run things through the horse sale and until the position could be filled. The board was so pleased with the job she did through the sale, they voted her in as executive director in July of 1994.

During Yvonne's tenure as Executive Director she has seen and participated in many changes in our industry outlasting our past five Presidents and many Board Members.

In 1994, she helped shepherd in SB1208 which established \$40,000 stallion award fund and guaranteed the breeders award fund at least \$800,000. That established extra money paid to any Arizona bred finishing first, second or third in any race in Arizona.

In 1995, she was instrumental in the passage of SB1384 which helped secure the future of Rillito Park through simulcasting. In 1996 she received the Julep Cup award for outstanding service in the Arizona Thoroughbred industry. Lived through the flood of 2003 at the breeder's office at Dr. Rizzonico's vet clinic. Then was instrumental in the move of the breeder's office to the grounds of Turf Paradise. Helped the Retired Racehorse Act of 2004 get passed, establishing the fund that saves retired racehorses and provides them with a new careers.

During the state's budget crisis that started in 2008, Governor Brewer swept our breeder's fund and left us unfunded. Again, Yvonne went back to work with the help of Marvin Fleming and Elaine Arena, the ATBA lobbyist, and secured \$250,000 from the state

budget to our breeder's fund beginning in July 2012. Special thanks to President Pierce, Governor's chief Klein, Representative Carter and Speaker Tobin for their support. Even though she heads towards retiring her position, she has been relentless in our cause of bettering Arizona bred racing.

In addition to all of her accomplishments, her favorite one has been the growth of the Arizona Breeders' Day into the Fall Festival. Where it has grown from just over \$82,000 of purse distribution in 1993 to \$222,000 paid out in purses, in 2012. Establishing the Fall Festival as the biggest and best day of racing in Arizona.

In an industry that has seen so much change over the past eighteen years, there has been one constant for the ATBA Organization, leadership provided by Yvonne Kunz. She was lovingly deemed "The Boss Lady" by Lyman Rollins many years ago, because he said "when anything happens or gets done in the breeder's organization, it's because the Boss Lady makes it happen".

The entire organization is grateful for your untiring years of dedicated service and we wish to honor her by sending her to the 2012 Breeders' Cup. We hope she enjoys her trip watching the best in the industry compete, because that day we send the best in our industry.

NOTIFICATION OF REDUCED LICENSE FEES FOR SOME RETURNING LICENSEES

RETURNING HORSERACING LICENSEES

If you are a returning licensee that received a three-year license prior to July 1, 2011 that expired on June 30, 2013 when issued, you may be eligible for a reduction in your license fee.

On July 1, 2011, new license fees became effective and an Arizona racing license was reduced from a three-year license to a one-year license. The Racing Commission approved the new fees and the new license term, which shortened the expiration of those licenses issued prior to July 1, 2011 by one year.

During fiscal year 2011-2012, the Department reviewed the license fees approved on July 1, 2011. We found that several of those license fees had been set too high. We adjusted those fees and brought the adjusted fees before the Racing Commission on June 22, 2012. Those fees were approved and went into effect on July 1, 2012.

The Department has also taken into consideration those returning licensees who lost the last year of the three-year license they purchased during the last license cycle. The Department has decided to credit those licensees with a pro-rated adjustment that equals what would have been charged if they had purchased the license during the third year of the three-year cycle.

This adjustment is a one-time reduction of fees and only applies to those licensees issued a three-year license prior to July 1, 2011. The reduction will be offered from July 1, 2012 through June 30, 2013 to returning licensees who meet these criteria and apply for a new license in the same license category.

A chart showing the license categories and reduced fees is posted at each horseracing licensing location.

Treating Two Activities as One for Tax Purposes

Sometimes a farm, livestock or horse activity may be closely connected to one's principal occupation, with certain tax advantages. If two activities are treated as one, deductions and income from each activity can be aggregated in deciding whether the taxpayer has the requisite profit motive under the IRS hobby loss rule. This is extremely helpful for many people involved in farming, ranching and horse activities.

For example, a livestock insurance agent might combine that business with his ranch, and aggregate the profits and losses. Or, an architect of horse farms might combine that with his horse breeding activity. Or, an animal supply business might combine that with its dog breeding-showing venture.

In one Tax Court case a holistic dentist argued that his apple farm was unified with his dental practice because patients got samples of his apples and were encouraged to eat them--so that expenses of his dental practice included the costs of operating the farm--but he lost. [Zdun v. Commissioner, T.C. Memo 1998-296.] In another case an attorney argued that his law practice was closely associated with his polo activities because his clients consisted mainly of people met at polo games, and competing in the events enhanced his reputation among clientele. He also lost. [De Mendoza v. Commissioner, T.C. Memo 1994-314.]

However, Tracey Topping of Wellington, Florida, won an important Tax Court case on this point. [Topping v. Commissioner, T.C. Memo 2007-92.] She argued that her equestrian related activities and her interior design business (for barns and second homes) were a single integrated business. She argued that her equine activities were necessary to her success as an interior designer. She deducted substantial horse activity costs against her income as an interior designer, and the court ruled that these expenses were ordinary and necessary advertising-promotion expenses associated with her design business.

The court said that her competing at horse shows created goodwill that benefited her design business, that she marketed the business by competing in horse events, and that her prominence as a competitor created good will that benefited her design business.

The whole idea is that there was one activity--the horse activity being unified with the interior design business.

In deciding whether two or more undertakings may be treated as one, the IRS will consider if the activities are sufficiently interconnected, the degree of organizational and economic interrelationship, the business purpose served by conducting the activities together or separately, and the similarity of the undertakings.

Ms. Topping's approach, approved by Tax Court, consists of entering in an attending horse shows, and making contacts with prospective clients at the shows. She later sets up meetings with them. When she competes her name is announced over the loudspeaker and flashed on the leaderboards.

Ms. Topping also relies upon trainers both to refer clients and improve her performance as a competitor. Every one of the trainers that she has worked with has referred at least one design client to her. She also engages a C.P.A. to handle her accounting matters.

The court said that Ms. Topping's success as an equestrian competitor creates good will that benefits her design business. She had competed for sport since a young age, and she transformed this sport experience into a way to establish goodwill as an interior designer.

The court said that her equestrian activities "significantly benefit her design business, and we find a significant business purpose for the combination of these undertakings. Her performance as a competitor has gained respect among her peers and causes them to seek her out when they are in need of a designer for their horse barns and recreational homes.

A single set of books and records should be used to track both undertakings, and both should be filed in the same Schedule C.

Early on in her business, she tried to develop clients through her longtime experience playing golf. When golf failed to produce any clients, she dropped her golf club membership.

The IRS had faulted Ms. Topping for not using conventional advertising (e.g., equestrian magazines or banners at horse shows).

However, the evidence showed that traditional advertising of a personal service business is not welcomed by the clientele Ms. Topping sought.

The court said: "Further, the evidence demonstrates that petitioner demonstrated good business judgment. Her equestrian contacts are responsible for more than 90 percent of her client base, and her overall business produced a sizable net profit for all of the years at issue. Therefore, petitioner has not only demonstrated that she honestly believed that her mode of advertising would turn a profit, but also has proven that it has been successful and that adopting [the IRS's] suggestion would probably have backfired."

The court concluded that Ms. Topping's design business materially benefits from her equestrian-related activities, whereas in the above-mentioned cases involving a dentist and a lawyer there was only an "incidental" benefit.

"The evidence demonstrates that petitioner's involvement in the equestrian world is the cornerstone of her cultivation of relationships with her clientele. Given the nature of petitioner's clientele, we find her testimony about the relationship between her equestrian-related activities and her design to be credible and logical."

Not everyone can qualify in treating two activities as one under IRS Regulations, and it is important to consult a tax attorney to see if your situation meets the criteria, or what objectives need to be met in your situation to qualify.

Derby for three-year-olds. Starters shall not exceed twelve. To start in the Derby all entrants must pay \$300 to pass the entry box by the usual time of closing for the Derby. In the event there are more than twelve at the time of entry, the starters shall be determined at that time with preference given to those entries that have accumulated the highest earnings, with winners preferred regardless of earnings. Entries not drawn into the body of the race will be placed on an also-eligible list in order of preference. In the event of a scratch in the body of the race prior to the official scratch time, entries on the also-eligible list will be moved into the body of the race based upon their order of preference. In the event that two horses have the same amount of earning position on the also-eligible they will be determined by lot.
