

Since 1967 the Arizona Thoroughbred Breeders Association has had an influence on almost all aspect of racing laws and regulations which has benefitted all horsemen running in the State of Arizona.

The goal of the Arizona Thoroughbred Breeders Association is to serve its membership and to grow into a strong viable organization with the ability to purchase land and build our own sales pavilion.

(May - \$25,000 bonus paid to an Arizona-bred winner, October - \$100,000 bonus paid to an Arizona-bred winner)

# SUPPORT THE PAST, PRESENT AND FUTURE OF THE ARIZONA HORSE BREEDING INDUSTRY

It is a critical time for the Arizona breeding industry as we face a loss of substantial funding. As you know, the small amount of stopgap funding that we previously received annually from the states general fund to pay quarterly breeder awards have been discontinued for 2016. However, there will be breeder and owner awards paid at the end of the race meet from the horsemen's purse account. Additionally, as of June, Turf Paradise management is withholding the funds we receive under a provision of the contract between the HBPA and Turf Paradise. This punitive measure essentially strips us of our last source of funding. It is quite simple, without funding the ATBA can no longer exist.

Without racing industry support we are struggling for survival in a business we all love and dedicate our time to. Most states with pari-mutuel wagering know the importance of a healthy breeder's incentive program to assist the racing industry with a population of horses in order to have a successful racing meet where all participant's involved can flourish.

Breeder incentives provide race track management with solutions to challenging issues such as the lack of horse population, short fields, a limited number of races on a race card and from cutting the number of live racing days from the calendar each year. These issue's could be resolved to satisfy the betting public and increase the on track handle with a supply chain of horses, but only if the Arizona breeders are rewarded with an incentive program.

Incentive programs have been legislated to created a local base of horses in each state. The local horsemen benefit by having more horses in their shed rows, more opportunity to win races and it essentially helps them achieve their goals of being profitable at the end of a race meet.

The local breeder's benefit with a reward for their initial investment in breeding their mare to a stallion and raising a foal. The incentive helps to showcase their efforts as the yearlings bring higher prices as they pass through a sale ring or obtain earnings from winning at the race track. It also encourages the breeder to produce the best horse they can and they will continue to breed more stock as the demand grows. "All states with pari-mutuel wagering understand this concept and have implemented breeder incentive programs through the support of the racing industry".

In Arizona the belief is that increased purses for Arizona-bred horse's will remedy the lack of horse population, when in reality a purse increase only fixes a small portion of the many problems. By relying on out of state horses to fill the stalls at Turf Paradise we are also relying on out of state economies and outside breeder incentive programs to be healthy.

It is an important time for breeders to become proactive in developing a permanent incentive plan. Imagine the reappearance of

money that would be invested back into the local economy by supporting the people that stay here year around, paying property taxes, employing people, and supporting Arizona vendors/business owners (feed stores, horse supply companies, trainers, veterinarians, agriculture) including the local racing industry. Incentive programs clearly strengthen the economic impact of jobs and the quality of horses racing within the state.

California considers this an important part of the state economy. They have built a very strong incentive program for the breeders, who have responded by producing nearly 50% of all racing entrants that are Cal-bred horses.

Even smaller racing venues in the state of Colorado have 36 days of live racing days with 10 off track betting (OTB) sites that generate more than \$1.3 million for their breeder's incentive fund. Colorado has already experienced new breeders bringing stallions to their state and mares being shipped there to foal. The majority of state's with legislated pari-mutuel racing realized the value of a successful breeder's incentive program and developed a lucrative fund to support the local breeder's. The development of the fund rewards all involved and creates a superior "supply chain" of horses to enhance a greater racing venue.

A review of 26 pari-mutuel states showed that the foundation of breeders incentive plans are funded by a percentage of the racing industry income. Each state is slightly different, but the money is deposited into the breeder accounts through various types of funding such as a percentage of pari-mutuel handle, simulcasting handle, advanced deposit wagering, slots (racino tracks only) breakage, un-cashed tickets, video lottery terminals (VLTs), or a combination of all. Delaware and Arizona are the only pari-mutuel states that are relying on the general fund

(use of state taxpayers money). Which is not a permanent funding stream and is now failing the breeding industry. (Review Breeders Incentive chart on page 11)


Arizona breeders were once funded in the same manner as other pari-mutuel states. As recent as 1994, Arizona breeders were aided by a pari-mutuel tax that was eliminated as a hardship for the race track to pay down debt. The fund for the breeders was approximately \$800,000 annually. This type of funding needs to be reinstated in order for the horse breeding industry to maintain a foothold in Arizona.

Without reinstatement of a permanent revenue stream for a "Breeders' Incentive Program" in our state the effects will carry a significant blow to the local breeders. They will disappear from the landscape and nothing will fill the void left behind.

The Breeder Awards were divided among all breeds of horses and included greyhounds. The money is paid out quarterly per the statutes and regulations. Thoroughbreds (the largest certified population) received about 80% of the funds. The funding line was replaced by the states unclaimed property (general fund) as they realized that support was necessary.

The breeders were then deemed statutory recipients of the state general fund, until tough economic times hit hard and the \$250,000 for breeder awards were discontinued to help balance the state budget. Arizona Annual Commission Reports show that when the permanent source of money was replaced with a lesser amount (of \$250,000 and then were discontinued in 2011-2012) a decline in state foal crops began to "spiral downward" and the small breeder could no longer afford to breed a mare back to a local stallion.

Other commercial breeders began to diversify their broodmare bands into other neighboring states where healthy breeder incentives exist. Arizona is no longer paying stallion awards to owners (stallion awards were discontinued in 2011 and no longer exist) and with that went many stallions to other states. "The reality is that the Arizona Breeders are considered stakeholders, but have no stake! And the Breeder Awards should have never been anything but the racing industries financial duty."

With the closing of Yavapai Downs much has happened with the takeover of the simulcast handle, which equated to approximately \$7 million and was split between Turf Paradise and the horsemen's purse account, with the Arizona Breeders (known as a third party stakeholders) were left out in the cold. The simulcast handle is considered a windfall that should have benefited all stakeholders. It would have been an easy solution to have the simulcast income divided equally among Turf Paradise, the Horsemen's purse account and a Breeders Incentive Program. The income to the breeders would have created a "spiral up" effect and the increase of income would have been flowing back into the local horse breeding industry and our economy. It would have stabilized the declining foal crops and growth in horse population would have developed. (see page 11 for comparison of foal crops in neighboring states)

The closing of Yavapai also created a great loss in income to the local horsemen. The loss of purses earned by Arizona horse's during the meet was over \$2 million alone. The loss of racing at Yavapai was devastating to the state breeders, as it was largely populated by Arizona-bred horses and the breeders would have received another quarterly award. These participants at Yavapai aided the Phoenix racetrack by racing until the end of the meet, when other horses were preparing to leave the state for summer racing. These local horses would also show up at the beginning of the Turf Paradise meet ready to go when the track was open for business, while others were still on the road.

At this time the lack of a viable breeder incentive program seems to be the largest problem we are facing and no one has put an offer out as a solution. These are just a few possible remedies that are not being listened to or we are simply being met with a "no" answer. Turf Paradise is penalizing the Breeders Association by withholding our income and is demanding that we use the funds solely for purse enhancements.

The disbursement of funds for running the Breeders Association has not changed in 25 years. In our opinion, this is a punitive attempt to discourage the breeders from seeking alternative sources for funding that have been opposed by Turf Paradise. If, in fact, Turf Paradise is successful in withholding our income we will soon be unable to continue operation of our association.

Now is a crucial time for us to come together as a group to appeal to all parties for a solution. There is a civic duty that requires government leadership to step in when one entity (Turf Paradise) is destroying the livelihood of so many people.

We can no longer attempt to resolve these issues we are facing as individuals. Our numbers are great and we will be at a disadvantage if we continue to be divided. Please remember, breeders are horsemen too.

All of us must collectively ask our State Representatives and our Governor to join in to help revive a part of the industry that is vital to the success of all the Arizona horse breeders.

# MARYLAND'S INCOME TAX SCHEME DECLARED UNCONSTITUTIONAL

A disturbing feature of American taxes is the way some states tax the income of its residents earned both within and outside the state, as well as income earned within the state by nonresidents. Carly Fiorina, former Hewlett-Packard CEO and now presidential candidate, filed 17 state income tax returns last year. Many Americans file multiple state income tax returns in states where they do not live or work, but where they own a business or have income-producing activities. Ordinarily, the home state will allow residents a credit on income taxes paid to other states.

Often horse owners, ranchers and farmers incur income in various states. For example, a racehorse that wins purses in California and in New York will realize income for the owners who reside in other states. A show horse being trained and then sold in another state will incur income for the nonresident owner. Income earned in multiple states by horse winnings can create a huge pile of state tax returns, even though you will usually get credit.

The way it works is that your home state taxes you on all your income; states where you don't live might tax you on the income you earned in those states. The home state usually will credit you back for income tax paid on income earned in other states, but not always.

The U.S. Supreme Court recently decided a case involving this feature of Maryland state taxes. [Comptroller of the Treasury of Maryland vs. Wynne.] The case considered Maryland's policy to not offer its residents credit against the income taxes they pay to other states. This resulted in double taxation of income earned by Maryland residents outside the state. The Supreme Court considered the issue of multiple taxation by denying residents a credit on income taxes paid to other states. It held that Maryland's tax scheme violates the Commerce Clause.

Some states have bilateral agreements with other states. For example Virginia residents who earn income in Maryland pay tax only to Virginia, and vice versa.

States that have no income tax are: Alaska, Florida, Nevada, South Dakota, Texas, Washington and Wyoming.


The IRS has long had a program of sharing tax information with state taxing authorities. Thus, if you face a state audit, the state agency will have access to your federal tax returns. State agencies usually have computer links with the IRS. If you are audited by the IRS, your state may automatically find out.

Most state tax collectors operate similarly to the IRS. They may accept installment payments, levy assets, or settle tax bills. State agencies also provide appeal rights if you disagree with the results of an audit.

"Loose tongues sink ships" is a saying applicable to tax audits. What you say can and will be used against you. That's why it's prudent to have representation, especially if the tax liability at stake is significant.

If audited by state or federal authorities, it's crucial to have good documentary evidence to substantiate deductions and to show that your activity is conducted in a businesslike manner. Usually the auditor will issue a list of things wanted. Your representative may be able to whittle this down, and should only provide those documents requested as well as anything that may help show the strengths of your business model. In audits of horse, livestock and farming activities where there are losses, the auditor will be particularly skeptical, so that you would benefit from representation by someone experience in your particular industry. \mathbb{F}

The Oak Tree Distaff is a restricted stakes race (part of the Golden State Series, created to incentivize the breeding industry) for fillies and mares who have foaled in California or whose sire stands in California.

Tribal Gals "dual eligibility status" has allowed her to earn over \$260,000 in restricted stakes races in California and over \$90,000 in stakes races in Phoenix, Arizona. Trainer R. Kory Owens and John Pendergast have precisely managed every racing opportunity for Tribal Gal to earn over \$445,801 in lifetime earnings. Prior to capturing the Oak Tree Distaff, Tribal Gal won the Ann Owens Distaff Handicap on Arizona Breeders' Festival Day in April and shipped to Santa Anita to finish third in the \$150,000 Spring Fever Stakes.≠



# LADY JILA DEFENDS HER TITLE IN THE \$40,000 MOLLY BROWN STAKES AND WINS THIRD STRAIGHT COLUMBINE STAKES

ARAPAHOE PARK, AURORA, COLORADO • JUNE 14, 2015

Lady Jila defended her title winning the Molly Brown Stakes as she set the pace early in the six furlongs sprint. Lady Contender challenged down the back stretch and Stormquility stalked along the inside rail passing the half mile pole. It was a dueling stretch drive with Stormquility putting in a game effort to wire, but Lady Jila proved to be the best and won be a head.

In addition to the Molly Brown Stakes victory, Lady Jila fired back a month later and won the \$40,000 Columbine Stakes on July 26, 2015. This was her third straight win in the Columbine Stakes. Ridden to victory by Mike Ziegler and trained by Sharlot Martinez, Lady Jila covered the route of ground (1 1/16ths miles) in 1:47.73.

She pressed the pace early and made her bid for the lead on the final turn. Entering the home stretch she drew clear by three lengths ahead of her rival Lady Contender, who held second. Lady Jila earned a total of \$48,000 with these two stakes victories in Colorado. She was bred in Arizona by owner Michael Barro, who has had much success with his eight year old mare.



Az Ridge is considered one of Arizona's top sales graduates. As an older gelding, Az Ridge's victory in the \$75,000 Brooks Fields Stakes gave owners Sawyer Cattle Company their fourth straight stakes win. Trainer Dan McFarlane has been spot on with placing him carefully in stakes races where he has earned over \$145,000 this year.

Az Ridge was the odds on favorite going into the Brooks Fields Stakes. He broke from the gate and went head to head with Number Five racing into the first turn and held the lead setting the pace down the backside. Entering the final turn and into the upper stretch Az Ridge drew off by 2 1/2 lengths covering the one mile turf course in 1:35.91. El Seventyseven finished second and Honor The Kitten held third.

Prior to shipping to Canterbury Park, Az Ridge captured the Turf Paradise Handicap, set a new track record in the Wildcat Handicap and captured the 1 7/8 miles on the turf in the Hasta La Vista Handicap. Az Ridge put in a tremendous effort in the Hasta La Vista winning at this marathon distance by seven lengths.

After winning the Brooks Fields Stakes, Az Ridge was entered into the \$100,000 Mystic Lake Mile Stakes at Canterbury Park. Looking to capture his fifth stakes victory he stalked the pace with his regular jockey Giovanni Franco and raced three wide down the backstretch. Az Ridge put in a strong drive entering the home stretch, but lost by a head bob in a close photo finish at the wire. Pumpkin Rumble took the honors in the Mystic Lake Mile by a nose.

Mid summer the connections decided to enter Az Ridge in the \$350,000 American St. Ledger (G3) going one and 11/16ths miles on the turf at Arlington Park. He raced just off the pace setter Alpha Kitalpha throughout the course and took the lead at the 13/8ths pole, but leveled off and finished fifth earning \$10,975. The American St. Ledger was carded as the 7th race on August 15th, which was Arlington Million Day. Az Ridge was an \$8,500 purchase from the ATBA 2010 Yearling & Mixed Sale. He has certainly proven to be a superior turf horse and his racing career is getting better and better. \mathbb{F}

# MID-YEAR UPDATE: Significant Progress Made in Adoption of National Uniform Medication Program



In the last six months, the horse racing industry made significant progress toward the uniform adoption of a national medication program, as regulators in a number of additional jurisdictions adopted reforms developed by the Racing Medication and Testing Consortium (RMTC) and enacted as model rules by the Association of Racing Commissioners International (RCI). The "Program" includes a Controlled Therapeutic Substances (CTS) list, third-party administration of furosemide, a multiple medication violation (MMV) penalty system and a requirement for laboratory accreditation and participation in an industry external quality assurance program.

"Working with jurisdictions to facilitate adoption of the National Uniform Medication Program is a top RMTC priority," stated RMTC Executive Director Dr. Dionne Benson. "While we are encouraged by the progress made thus far, we anticipate even more progress in the upcoming months."

Over the last year and a half, racing states adopting the Controlled Therapeutic Substances list have increased from four to 15 – a 275% increase. These states represent over 70% of the national pari-mutuel handle. The CTS establishes strict regulatory thresholds and provides withdrawal times for 26 specific medications that the industry believes to be necessary for the routine treatment of illness or injury in the horse. It was most recently put into effect last month in Minnesota, which joined Arkansas, California, Delaware, Indiana, Kentucky, Maryland, Massachusetts, New Jersey, New Mexico, New York, North Dakota, Pennsylvania, Virginia and West Virginia in regulating therapeutic medications using the medication schedule.

"On June 27, the Minnesota Racing Commission rules were modified to adopt all the uniform medications and thresholds on the CTS list, as well as RCI endogenous substances including cobalt," said Minnesota's Chief Commission Veterinarian Dr. Lynn Hovda. "The commission has worked diligently over the past two years to stay current with RMTC and RCI recommendations and rules and will continue to do so."

When the Pennsylvania Equine Toxicology and Research Laboratory received RMTC Interim Accreditation in March, Pennsylvania became the 24th horse racing state to utilize an RMTC-accredited lab and an external quality assurance program for its equine drug and medication testing services – up from just six racing states 18 months ago. The laboratory accreditation and quality assurance programs are modeled on gold standard human protocols established by the World Anti-Doping Agency and ensure that all laboratories are operating at the same high level of proficiency. This consistency fosters uniformity and strengthens both the integrity of racing and the safety of its human and equine athletes. Pennsylvania joined Arizona, Arkansas, California, Colorado, Delaware, Idaho, Indiana,

Kentucky, Maine, Maryland, Massachusetts, Minnesota, Nebraska, New Jersey, New Mexico, North Dakota, Ohio, Oklahoma, Oregon, Washington, Virginia, West Virginia and Wyoming in solely using RMTC-accredited lab testing services. Laboratories in New York and Texas are currently in the application process.

The number of commissions that have implemented the MMV penalty system has increased 200%, from three in January 2014 to nine today. The MMV penalty system creates a tracking system for an individual's violations and provides for enhanced penalties for those who accumulate multiple medication violations, regardless of the jurisdiction in which they occur. Arkansas, Indiana, Maryland, New Jersey, North Dakota and West Virginia commissions have joined Delaware, Massachusetts and Virginia in implementing this system.

Commissions requiring third-party administration of furosemide (commonly referred to as Lasix) on race day have risen from 13 in January 2014 to 16 – a 23% increase. This policy, which is a key component of the Program, effectively restricts the access of private veterinarians to horses on race day. Arkansas, Florida and Pennsylvania have joined Colorado, Delaware, Indiana, Kentucky, Maine, Maryland, Massachusetts, Minnesota, New Jersey, New York, North Dakota, Virginia and West Virginia in implementing the regulation. In June, the California Horse Racing Board announced that it is in the final stages of adopting and implementing the policy in that state.

States adopting the Program in its entirety have now reached nine jurisdictions with the full implementation of the Program in West Virginia last month.

"We continue to urge all U.S. horse racing jurisdictions to adopt the reforms in their entirely without further delay," said Alex Waldrop, chairman of the RMTC and president and CEO of the NTRA. "Uniform adoption of the National Uniform Medication Program is critical to industry participants and fans alike, so we continue to make the RMTC and its very capable staff available to assist any state seeking to implement the Program."

The RMTC consists of 23 racing industry stakeholders and organizations that represent Thoroughbred, Standardbred, American Quarter Horse and Arabian racing. The organization works to develop and promote uniform rules, policies and testing standards at the national level; coordinate research and educational programs that seek to ensure the integrity of racing and the health and welfare of racehorses and participants; and protect the interests of the racing public.

Aware's next stakes outing was in the La Verendrye Stakes, where she finished fifth. She bounced back in July to capture the Canada Day Stakes by a neck. Aware paid \$21.40 for the win over *Can't Use Nellie* who fought gamely in the stretch drive but could not out last Aware's bold effort. *Go Go Lolo* was the betting favorite and finished third.

Aware was honored as the Champion Three-Year Old Arizona-bred Filly in 2014. She won the Chandler Stakes and the Joanne Dye Stakes at Turf Paradise last year and has lifetime earnings of \$128,620.

Aware was bred by Dennis Weir and is sired by El Roblar out of Glassford Hill. Congratulations to owner Barry Arnason and owner/trainer Don Schnell.


