NO SUPPLEMENTAL NOMINATIONS

ATBA will offer \$15,000 in bonuses as follows:

If yearlings passing through the 2016 ATBA sale	\$ 5,000
If Certified Arizona-bred	\$10,000
If Certified Arizona-bred and passed through the 2016 ATBA Sale	\$15,000

Eligibility: *Restricted to all foals of 2015.* **Starters will be limited to twelve.** To start all entrants must pay \$500.00 to pass the entry box for the trials (if needed) or finals at the usual time of closing for that racing day. Sufficient trials (if needed) will be run to accommodate all entrants with no more than ten horses. The twelve qualifiers and four preferred horses will be posted by the racing secretary the following morning. The ATBA will deduct 5% of all nominating and sustaining payments for clerical fees. The purse will be divided 60% to the winner; 20% to second; 10% to third; 5% to fourth; 3% to fifth; 2% to sixth.

Nominations are transferable if ownership changes, however, it is the responsibility of new owners to notify the ATBA and make all sustaining payments to participate in races. Eligibility of horses nominated to the Turf Paradise Open Spring Futurity are subject to compliance with Arizona Rules of Racing under the supervision of the Arizona Department of Racing; Arizona Racing Commission; The Racing Secretary at Turf Paradise. Turf Paradise reserves the right to cancel or postpone these races and or trials for these races for any reason which it deems good and sufficient. Conditions of these races may be altered due to unforeseeable circumstances. In the event of cancellation, nominating and sustaining payments already made will be refunded to appropriate parties less the administrative fees stated herein.
