Miss Malia settled off the leaders early, moved four wide through the turn and finished with a steady bid. Booze Runner drew clear by 2 3/4 lengths nearing the wire and won the 2022 ATBA Sales Futurity (Fillies Division). Due to covid, this race was delayed and ran as three year olds. The fillies division purse was \$55,424. The winner's share was \$25,236 and the final time of the 6 furlongs was 1:10.89. Booze Runner was purchased out of the Keeneland September 2020 sale by C J Racing. She was consigned by Bar Diamond Ranch to the Arizona ATBA Sale which made her eligible for this futurity. Booze Runner began her juvenile racing career in california and returning to Arizona after Del Mar. Booze *Runner* is owned by C J Racing. 

Ramblin' Man settled at the rear early, began to gain inside approaching the half, took the lead inside of Famous Rock Star at the quarter, continued to lead while pursed by Hey Pilgrim down the lane. Hey Pilgrim settled near the rear with is stable mate, improved four wide from near the half mile mark, loomed four wide past the three eights, continued to chase Ramblin' Man down the lane while that pair separated from the rest of the field, gained late on Ramblin' Man but missed. Famous Rock Star was sent between horses, led in the opening furlong, tracked three deep after Mystic Reality took the lead near the five eights, led briefly again past the tree eights while positioned three wide. Moonlite Graham came away well but settled back to chase the leaders, Mystic Reality was sent inside for speed, set the pace and flattened out, Smooth Papa attended the early pace between horses, flatten near the five furlong mark, raced with the trailing pair, was empty for the drive.

## **Robert Harley "Bob" McKee** Oct. 26, 1931 - Feb. 23, 2022



Bob Mckee 90 years, passed away on February 23, 2022 in Phoenix at the home he shared with his devoted wife of 44 years, Mary Ellen.

Bob was born on October 26, 1931 in Hamilton, Mo in the home behind the service station owned by his grandfather and run by his father.

As an only child, he attended elementary and high school in Cameron, Mo, prior to enrolling in William Jewell College in Liberty, Mo and majoring in Economic. Bob put in many hours delivering fuel, with an old tank wagon. On many cold nights, he recalled seeing lights on in the houses on Christmas eve, and wishing he was home. With a good education and a strong work ethic under his belt, he became the ultimate entrepreneur, eventually moving to Arizona in 1969.



Bob became a dynamic, independent gasoline marketer developing one of the largest independent chains of self-serve gasoline stations in the Southwest. He originated the concept of convenience stores, with one stop for the purchase of groceries and gas. He then branched out into banking, procuring Ralston Bank in Nebraska which he sold to Norwest Bank which then became Wells Fargo Bank.

He thrived on taking chances and could play a waiting game, unless there was a business opportunity that he couldn't resist and then Bob would just buy it. Bob once described his successful career as one of "dodging bullets". In 1988 he founded the Board of the Torrey Pines Club Corporation, after successfully acquiring the lease of the 36-hole municipal Torrey Pines Golf course owned by the city of San Diego, Ca. Torrey Pines Club Corporation serves to operate all aspects relating to the game of golf, from carts to clubs and everything in between. Bob served as Chairman until his passing.

He and Mary Eleen enjoyed the challenge of developing and operating, Hidden Springs Ranch one of the finest manicured horse facilities in Peeples Valley, Az. Bob truly enjoyed betting on the "Ponies" and poker with the boys in Del Mar. He enjoyed summers in Idaho floating around on his and Mary Ellen's boats, "Old man river and Me and Bobby Mckee" and participation in the follies around the "Tree Bar". Bob also sat on the Board of Directors at Turf Paradise. He and Walter Cluer were great friends.

Bob was preceded in death by his parents: Robert Doak and Helen William McKee, 2 precious grandsons, mother of his children: Peggy Kelly and a brother-inlaw: Richard Poulsen.

He is survived by his wife Mary Ellen, 2 daughters: Sherri McKee, her children Linden and Allen Foster and Marlowe (Kim) Quart, Kathleen McKee )Michael) Johnson, their children: Dustin (Christina) Johnson, Luke Johnson and Chelsea Johnson (Brian) Roberts, son Robert Thomas "Tom" (Tracey) McKee, their sons Harley and Matthew, 2 great granddaughters: Colette and Chloe Johnson, 4 brothers-in-laws: James (Davey) Campbell, Calvin Craig, Terry (Jean) Poulsen, sisterin-law: Gail Poulsen and 9 nieces and nephews.

He also leaves behind the devoted staff of Torey Pines Club Corporation and Hidden Springs Ranch, many who have been with Bob and Mary Ellen for over 33 years. We are all so grateful for all of Bob's caregivers for so many years and Hospice of the Valley in his final days. A private family service was held in his memory.



## Crims' Homebred Desert Dawn Brings Light to Arizona

When H and E Ranch's homebred Desert Dawn missed the mark in the sales ring in 2020, Elena and Hollie Crim took matters into their own hands.

Buying back their filly for \$32,000—in what Elena describes as a decision she initially thought was "foolish"—might have turned out to be one of the best she has ever made. The 3-year-old Arizonabred daughter of Cupid will contest the May 6 Longines Kentucky Oaks (G1) at Churchill Downs, the lone filly in the 14-horse field not bred in the state of Kentucky.

Growing up surrounded by horses, it felt natural to Elena to continue the profession. She says she married her late husband Hollis, a cowboy, when she was 20, and spent several years working on cattle farms.

"They've been my passion," Elena said. "My father's family and my family have been in horses all of our lives. Because we've been so dedicated to them, you just branch out... They're a magnificent animal and once you're addicted to them, you can't imagine doing anything else. It is what it is."

After Hollis died two years ago, Elena's daughter Hollie, who also works as a lawyer, stepped in to help support the family horse business.

Based out of Globe, Ariz., the mother-daughter pair foal out a few mares in their home state every year, with the majority of their horses staying in Kentucky and Florida.

"I just feel like I need to support (Arizona) because I've been in the business for so many years, so I try to have around three to four mares foaled here," Elena said. "Some horses stay in Kentucky permanently and the ones that I'm very attached to, like Desert Dawn's mother, come back and forth to me.



"The ones that I choose to stay there in Kentucky stay with Callan and Frankie O'Connor. Same as in Florida. They stay down there if I'm not emotionally attached to them."

Hollie Crim and the connections of Desert Dawn The Crims are regulars at sales across the country, especially those in California and Florida, enjoying the chance to spend quality time together doing what they love.

"We used to try to go to all of them, but especially the ones that were easier to get to like the ones in California and there was a small sale in Arizona we used to do," Hollie said. "Truthfully, we're just excited to get to go back to Kentucky with Desert Dawn. It'll be nice to see our horses back there. It'll be a lovely trip.

"You know, it's just a true pleasure and a true honor to get to do this business in general with my mom. I'm really lucky I get to do what I love with someone I love. To get to have one of our own horses that's from a family line we've loved for years (run in the Kentucky Oaks); it's just incredible. It's surreal." Hollie, who refers affectionately to Desert Dawn as "Ally," has been part of the filly's journey every step of the way. Elena recalls when her daughter foaled out the filly's dam Ashley's Glory, who is another homebred, at their farm.

"Desert Dawn has been so fun because my daughter delivered that baby here on my property... she did a great job and she named her too. She does a lot of hands-on stuff for being as intelligent as she is; she's a lot smarter than I am," Elena said. Trainer by Phil D'Amato, Desert Dawn has earned \$378,400 in seven starts, including an upset in the Santa Anita(G1) and Santa Isabel Stakes (G3). She also ran in the 2021 NetJets Breeders' Cup Juvenile (G1), where she finished sixth.

"Phil has known all along that she has this talent; he put her in a couple races and he knew how capable she was," Elena said. "They kind of ignored her when she ran in the Breeders' Cup, and rightfully so; she hadn't accomplished as much, but she still had ability and she certainly has proven it."



Elena was ecstatic when she watched her filly cross the finish first April 9 at Santa Anita Park, turning back grade 3-winning favorite Adare Manor in the process by a hard-fought neck and paying \$31.20 to win as the longest shot in the five-horse field.

"Good heavens, it was outrageous," she recalled. "We have a lot of dogs; I thought they were going to go bananas (because) I was jumping up and down. It was a very exciting race; it was very close. That's what Walt Disney talks about when dreams come true. It was just absolutely fantastic."

The Crims hope to repeat this success when Desert Dawn competes for the lilies this year, marking a milestone for their business.

"We've had a couple horses come close to \$300,000 in earnings but she's certainly the one... I would say Desert Dawn has definitely been the cream of the crop... It's huge, it's wonderful," Elena said.

Desert Dawn ran well in the Longines Kentucky Oaks, finishing gamely in the stretch but coming up short of winner Secret Oath in a third-place finish in the \$1.25-million race May 6 at Churchill Downs. Desert Dawn was the 2021 Champion Arizona-bred Two Year Old filly.

### **EQUINE CARE**

# Meds for MARES: Which ones are safe for pregnant mares?

Horse owners often wonder which drugs and medications are safe for pregnant mares and which ones should not be administered, and why, and if some might still be used and when. There are often more questions than answers on this topic, however, because very few drugs have actually been throughly evaluated and confirmed for validation of use in pregnant mares. Safety studies are usually done in geldings, rather than pregnant mares, and we can't always extrapolate from group to the other.

Dr. Margo MacPherson (professor Reproduction, College of Veterinary Medicine, University of Florida) says there is so little known about medications and pregnancy that mare owner's always need to discuss these with their veterinarians. "Even then, they can't expect their veterinarian to have a wealth of information on this topic because we just don't have that much data." she says. There have not enough studies in pregnant mares.

For example. very few dewormers carry a label for use in pregnant mares. There has been some research on certain drugs and medications, but mainly all we have is just anecdotal use that suggests the majority of commonly used drugs are relatively safe foruse in pregnant mares. The medications and drugs you'd use in pregnant mares cannot be adequately addresses in blanket statements, so mare owners should discuss each case with their veterinarian in terms of specific situations--with a valid client-patient veterinarian relationship.

"Any medications being administered to a horse should be discussed with your veterinarian. A horse owner or mare manager should never give anything to a pregnant mare without first talking to the a veterinarian. It;s always a case by case situation and a very open - case-ended topic, said MacPherson.

"There are times we have to treat the mare to treat the fetus, especially in-certain situation in late pregnancy. Early pregnancy is very different from late pregnant in terms of how something might affect the fetus. The foal's organs are all being formed in early pregnancy and some of the things you'd give a mare at that early stage might have more adverse effect on this development, acting as teratogens, " she says.

"There has been very little research about medication in mares at different stages of pregnancy, so when drugs are coming for approval through the FDA, adding the pregnant mare model changes everything. The physiologic changes in the mare during pregnancy are enormous; Her cardiac output is increased by about two-thirds, the way the blood flow is directed in the body, the way the kidneys operate, etc, are all affected by the pregnancy. There is a huge increase in fluid volume in pregnant women and in pregnant animals. The way the kidneys operate is very different than in the non-pregnant female," She explains

"In turn, these changes all affect how drugs are distributed in the body, and affect what the body does with them, and the way they are cleared from the body. There are a number of metabolic pathways that these drugs undergo. Depending on the pathway, research has barely touched on what's happening; our understanding, even in pregnant women, is very limited. Our data base of information about some of the metabolic pathways and the way the drugs are handled in the liver and kidneys is limited. We don't know enough about some of the pharmacodynamics of the drugs,"

"One of the things I've learned in my work is that the common expectation that all drugs pass the placenta (and get to the fetus) had to be reconsidered. We've had to rethink that idea. I've treated all drugs as though they pass the placenta, however, and I probably will continue to think that, in most cases--because, I am usually thinking about how a drug might affect the fetus, and not necessarily just the placentitis we're treating, for instance. If the mare has a respiratory infection, for example, can I give her ceftiofur sodium and have it be effective for treating her, without impacting the fetus? This is usually how I am thinking about it, rather than from the placentitis view in which I am trying to look at a drug in terms of it passing through the placenta and getting to the fetus."

She has done a series of studies looking at concentrations of certain antibiotics and anti-inflammatory drugs in the fetus and fetal fluids. "We have looked at penicillin and gentamycin and determined that they pass through the placenta and attain therapeutic concentrations for a period of time in the allantois fluid surrounding the fetus. We have looked at flunixin meglamine (Banamine) and didn't see whether or not it passed the placenta and we are not sure why. It may have been because the system we were using to measure it prevented it from passing, but we don't know--but we couldn't detect it in fetal fluids," say MacPherson.

"We have looked at trimethoprim sulfa, which crosses the placenta and also gets into fetal tissue. We have also looked at ceftiofur sodium and ceftriofur crystalline free acid (Excede). Neither of those pass the placenta very well; they have almost undetectable concentrations in fetal fluid and fetal tissue. This suggests that there is very limited passage of those antibiotics through the placenta, she explains. There can be many differences and this is why every drug need to be tested, " she said.

There have bee more studies in pregnant humans than in horses, but making extrapolations from human medicine to horses is risky because the type of placenta is very different in these two species. "Making extrapolations from rats to horses to humans is also very risky for the same reasons,' says MacPherson.

Dr. Peter Sheerin, Nandi Veterinary Associates in New Freedom, Pennsylvania )an equine practice with emphasis on reproduction) points out one things that can cross the placenta and affect the fetus can be different in horses versus humans. "One example is betamethasone. This steroid is used in a lot of pregnant women to induce maturation of the fetus," he says. It might be administered when a baby must be born pre-term or ahead of normal labor, to help the baby;s lungs be more prepared for functioning outside the womb.

This drug does not cross the placenta in appreciable amounts in mares, however, so it won't be beneficial if a mare is giving birth prematurely or if a foal must be delivered by C-section. Thus looking at human medications is not always the same as looking at medications in the horse.

"There is some fear of using corticosteroids in pregnant mares. It's well-known that giving a pregnant cow something like dexamethasone in mid to late destation can cause abortion, but mares are different. Steroids are usually fairly safe for mares, but this might depend on dose and duration. High doses of dexamethasone for multiple days have been given to mares to induce abortion in latepregnant mares, but we typically don't use those high doses for long periods of time, for treatment. A one-time low dose is generally safe for pregnant mares', says Sheerin.

"There are antibiotics that cross the placenta and some that don't-as far as we know. There are a limited number of the ones that we know cross the placenta, and a lot of the studies showings which ones so cross the placenta were done by Michelle LeBlanc and others who have done research with placentitis," he says. In that situation, you want an antibiotic that will cross the placenta and address the infection.

But one thing to remember regarding placentitis is that in mares with placentitis, the placenta is abnormal; the effect of the antibiotic might be different in a normal pregnancy. There is still a lot we don't know.," says Sheerin.

There are many other drugs and medications we routinely give horses such as dewormers, non-steroidal anti-inflammatories, tranquilizers, etc. That we might not think about the terms of how they might affect a pregnant mare or the embryo or fetus. "It is very important to read the labels, but some will state that they have not been tested in pregnant mares. This makes it more of a challenge, but there are some labels that say "do not use in pregnant mares and you can avoid using those,' he says.

"We use nos-steroidal antiinflammatories like bute and flunixin meglumine (Banamine) in pregnant mares, without issues, but the thing to remember is that they are used in moderation without issues. One moderate dose may be safe to use, whereas chronic administration might create problems, says Sheerin. If a pregnant mare is colicky you would probably go ahead and give her banamine. One dose might not be a problem, but if you had to keep her on it long-term it might become a problem.

The same is true with antibiotics. For example, with gentamycin we worry about issues in the kidneys with long-term use. We've seen foals born to mares that were on longterm gentamycin, and those foals had kidney issues." Even though there have not been formal studies, this problem has been observed so we know there can be adverse effects on the kidneys of foals.

"The important things are dose and duration, when it comes to giving medications to pregnant mares, and their potential impact on pregnancy and fetal health," he says. If you have to give medications, give them for the least time possible and at the lowest effective dose. Your veterinarian can help guide you on these decisions in terms of your own mare, on a case-by-case basis, depending on the condition being treated.

"This is a huge subject and we

don't know a lot about it," says MacPherson. "There are many factors that can influence drug absorption, metabolism and excretion, and it's hard to try to make judgment based on limited studies;we just don't have the information that we need. The handful of drugs I'm looking at are just the ones that are generally used to treat placentitis in the mare." she explains.

With the wide array of drugs we give horses today, it is difficult to make safe choices and have good judgment regarding what we might give a pregnant mare. "The mare owner's veterinarian tries to make judicious, therapeutic choices in treating something like placentitis, based on the fact that if you don't treat the mare, you don't treat the problem," she says.

Sometimes you have to treat a mare to save her life, and that's your first priority rather than worry about effects on the fetus. In her research in horses she first looks at all the literature on what we know in other animals during pregnancy, mostly humans. This is often the starting point, as we try to begin studies in horses. "These studies in horses are expensive to do, however, and I'd be surprised if we see much more information in the future about how drugs are handled in the pregnant mare,: says MacPherson.

The take home message on this topic for horse owners is that we don't enough to be able to make really good choices and decisions when giving medications to pregnant mares, and we need to be careful. It's imperative to discuss these things with a veterinarian.

## **Are Horse Syndications Coming Back?**

The Tax Court has recognized that horse racing or breeding is a highly speculative venture, but that "an opportunity to earn a substantial ultimate profit in a highly speculative venture is ordinarily sufficient to indicate that the activity is engaged in for profit even though losses or only occasional small profits are actually generated."

The possibility of just one successful racehorse or breeding champion could require purchasing a highly expensive animal or group of animals.

Sometimes a syndicate is formed to pool resources and minimize the risks. Syndication is a way of getting involved in racing, breeding or competing on a much higher level than individual ownership. For the owner-manager, it provides funds with which to purchase a horse that otherwise might be unfordable.

For many years, fractional ownership has been a means of buying into horse racing and breeding opportunities. This was particularly active in the 1980s and 1990s, when horse prices were steadily rising and more people wanted to join in earning profits.

There are several kinds of syndicates, but in principle the people who buy into the deal become co-owners of fractional interests in the racehorse, show horse or stallion, as the case may be.

A racing syndicate may take one of several forms. Typically, a specific racehorse is involved, and the manager is usually the owner of the horse. The syndicate members have decision-making powers, such as deciding when the horse will commence its racing career, be gelded, retire for breeding or stud duties, or whether to change the trainer or to sell the horse.

Purses are distributed to members pro-rata on a monthly basis. In addition to the price of shares, members may be required to pay a monthly maintenance fee. Upon termination of the syndicate, the manager is to divide the proceeds among the members proportionately.

If a horse is not a successful performer or is injured, each member's loss is limited to a fraction of the purchase price.

On the breeding side, stallion syndications are a viable means of buying into a super-stallion and spreading the costs of ownership among a group of investors. With a breeding syndicate, a stallion, whether a retired racehorse or show stallion may be transferred into a syndicate, and syndicate members (co-owners) are entitled to one free nomination per season. Members may choose to sell their annual nominations, and eventually a share in profits should the horse be sold. The entrepreneur who establishes the venture manages these syndicates. Each party is entitled to separately report tax deductions for costs and depreciation.

A syndicate agreement will state whether the horse is or is not insured. Members may obtain mortality insurance, however, on their individual fractional interests. The legal structure of the syndicate is usually a partnership, tenancy in common, or LLC entity.

Syndicates entitle people who are new to the horse industry to gradually get started in an activity that takes could end up be very rewarding, with a minimal outlay of cash.

Some syndicates have a set time frame, such as a year in which the horse will be raced, purse money distributed, and the horse sold at the end of the period. This enables investors to minimize risks, get earnings sooner rather than later, and often may involve a relatively modest investment, depending on the fair market value of the horse.

It is always important to know the qualifications of the syndicate manager, and to check out the pedigree and record of the individual horse or horses involved. Syndicate agreements are usually fairly straightforward documents, but an attorney should always review them.

Tax benefits may vary, depending on the type of agreement. For example, some racing syndicates are structured as limited partnerships, which may have a different allocation of tax benefits than a typical breeding syndicate. But generally, the co-owners may realize tax deductions for depreciation of their fractional interests and for maintenance fees.

Derby for three-year-olds. Starters shall not exceed twelve. To start in the Derby all entrants must pay \$300 to pass the entry box by the usual time of closing for the Derby. In the event there are more than twelve at the time of entry, the starters shall be determined at that time with preference given to those entries that have accumulated the highest earnings, with winners preferred regardless of earnings. Entries not drawn into the body of the race will be placed on an also-eligible list in order of preference. In the event of a scratch in the body of the race prior to the official scratch time, entries on the also-eligible list will be moved into the body of the race based upon their order of preference. In the event that two horses have the same amount of earning position on the also-eligible they will be determined by lot. In the event there are more than twelve at the time of entry, the starters shall be determined at that time with preference given to those entries that have accumulated the highest earnings, with winners preferred regardless of earnings. Entries not drawn into the body of the race will be placed on an also-eligible list in order of preference. #### ALL RACES WILL BE RUN UNDER THE FOLLOWING RULES.

All races will be restricted to 2022 Arizona-bred foals, registered and certified by the Arizona Thoroughbred Breeders Association. To be eligible to start in the Futurities or the Derby/Oaks foals must be registered and certified by February 1, 2024. The ATBA will deduct ten percent of all nominating and sustaining payments for clerical fees before each race. The balance to be divided as follows: Original and sustaining payments to be split 50% to the Futurities and 50% to the Derby/Oaks. (Futurities and Derby/Oaks monies to be split % by gender). Monies will be divided: 50% to winner, 20% to second, 10% to third; 5% to fourth; 3% to fifth; 2% to sixth; (in the futurity 1% to the next six finishers) (in the derby/oaks 1% to each of the next six finishers) and 4% to be paid to the nominator of the winner of each race. To remain eligible for the Derby/Oaks, horses do not have to start in the Futurities, however all sustaining payments must be made through October 15, 2024. To remain eligible for the Derby/ Oaks an additional \$300.00 is due January 15, 2025.

# Less Stressful Weaning Practices for Healthier Foals While it is typical to wean foals at 4-6 months, research indicates that there are steps breeders can take to make the process

more natural.



Especially in horse racing, the economical and practical reasons for early artificial weaning include marketing of foals, optimizing the mare's reproductive efficiency, and controlling the foal's nutritional intake, but how does this affect the foals?

Racing, sport and pleasure horse foals are typically artificially weaned between four and six months of age. Whether weaning is abrupt or more graduated, in all cases artificial weaning takes place when the foal is still closely bonded to its mother.

Along with maternal deprivation, foals generally experience other major life-changing stressors (e.g. changes in housing, feeding, and management, and increased human intervention). Weanlings commonly experience increased distress behaviours including decreased eating and sleeping, reduced play, increased aggression, weight loss, elevated stress hormone levels, increased heart rate, decline in growth, decreased bone density, compromised immune function, and an increased risk of respiratory and GI infection (e.g. Erber 2012). Weaning also leaves foals highly vulnerable to the development of stereotypies, described as chronic, invariant, seemingly purposeless behaviours such as cribbing, weaving, and self-mutilation (Warran et al., 2008).

Weaning has therefore been described as the most stressful event in a young horse's life (Henry et al., 2020; McGreevey et al., 2018). Given its profound negative impact, it is worth asking the question of whether weaning is necessary. As we will see, nature does a rather exemplary job all by itself.

#### Why is weaning stressful?

In natural conditions foals gradually transition to solid food as the mare's milk composition decreases in fat, protein and calories, encouraging foals to expand their diet. Foals stop suckling between nine months and more than a year (interestingly it is the foals who take the lead on this one), and by 10 months are spending approximately 60% of their time grazing, corresponding to that of a mature horse (Henry et al., 2020).

As opposed to artificial weaning, in natural conditions the close bond between the mare and foal is not severed at the cessation of suckling, or in some cases, ever. Research following foals over time find that foals gradually spend more time away from their mothers, but only become fully independent if and when they leave the herd at sexual maturity (at two or three years old). In a study of 16 mare and foal pairs of Icelandic horses living in natural conditions, Henry and colleagues found that even when foals were no longer suckling, and next years' foal was on the ground, weanling's still spent most of their time within one horse length of their mothers. They showed an equally strong preference for their mothers over other herd members after weaning as they had prior, and although they found new herd buddies as they aged, the mother always remained the most preferred partner (Henry et al., 2020; see also Crowell-Davis & Weeks, 2005).

A Canadian study by equine researcher Katrina Merkies from Guelph University compared traditional abrupt weaning to a potentially less stressful two-part weaning process (nutritional separation, followed by physical separation). Two-stage foals initially stayed with their mothers who were outfitted with udder covers which prevented suckling; after four days the mares were removed as in a traditional abrupt weaning. The two-stage foals showed no physiological or behavioural indicators of stress while they remained with their mothers with udder covers. However, once the mares were removed, the two-stage foals were equally as stressed as the abruptly weaned foals, with increased vocalizations, running, foal-to-foal aggression, and higher fecal cortisol levels. Merkies concluded that their results did not support the hypothesized stress-reducing benefit of two-stage weaning. More interestingly, however, their results spoke clearly to the fact that it is the physical separation of mare and foal that is by far the greater stressor for both, rather than the nutritional separation. Early artificial weaning has been defended by the fact that the mare's milk is no longer nutritionally adequate for the foal. Merkies research points to the fallacy of using food's nutritional value as a reference point for the appropriate weaning time.

Merkies' findings also mirror results from Harry Harlow's work with rhesus monkeys in the early 1960s. In a series of barbaric experiments removing infant monkeys from their mothers at birth and raising them with a "wire mother" who provided food (a wire mesh figure outfitted with a suckling device) and a "cloth mother" made of soft terrycloth, but that provided no nourishment, Harlow was able to show that it was not food that was key in the formation of the mother-infant bond, but what he called "contact comfort." The infant monkeys spend almost all of their time on the terrycloth mother, sought her out when frightened, and used her as a secure base to seek comfort when exploring a new environment; they chose the wire mother only when they had to feed and quickly returned to their cloth mother.

#### Many of these reasons are based more on habits and tradition, perhaps even on false beliefs, and clearly not on the prospects for improving the welfare of domestic foals.

Harlow's work formed the basis for Attachment Theory proposed by John Bowlby (1980, 1982) who proposed that attachment evolved as a way of maintaining bonds to close others for protection that was seen as critical to an infant's survival, bonds that are maintained throughout the lifespan. Attachment figures are not easily replaced, attachments do not decrease over time, and the grief upon loss is immeasurable. Even when attachment relationships are problematic and attachment figures do not provide the secure base and safe haven that the child needs, the attachment bond is no less persistent.

Although horses' attachment relationships may not be as complex as ours, there is ample evidence to support the fact that horses form enduring relationships with particular others and suffer when these relationships are ruptured (Warran et al. 2008). It is therefore an unlikely assumption that once a mare or her foal's weaning distress behaviours have subsided that they have simply forgotten about this integral attachment relationship, they have learned a necessary lesson in growing up, and they suffer no ill consequences.

#### How might we make it better?

There have been a number of graduated approaches to weaning that may make the procedure somewhat less stressful for foals (see "Reducing Weaning Stress"). The strongest evidence for reducing weaning stress are methods that leave the weanling with an unrelated but familiar adult mare or mares (e.g. Erber et al., 2012; Henry et al. 2012). Henry and colleagues found that although weaning was stressful for all foals (whether weaned alone, with other foals, or with other adults) foals were the least stressed when weaned with another familiar adult mare or mares. Interestingly, foals weaned with other foals (a ubiquitous industry practice) did not fare well, demonstrating more peer aggression, more abnormal behaviours, and higher cortisol levels.

#### A paradigm shift: What about not weaning?

Some graduated weaning processes may be better than others, but there is little research following these horses over time, leaving us with a paucity of knowledge about the long-term impacts of artificial weaning. Furthermore, graduated artificial weaning (which decreases suckling and increases separation) does a poor job of mimicking nature where suckling frequency does not decrease in the weeks prior to weaning, and mare-to-foal proximity remains stable before and after weaning. Finally, unlike any graduated artificial process, natural weaning elicits no stress reactions in either foal or dam (Henry et al., 2020).

Today, there are various economical and practical reasons for early artificial weaning: marketing of foals, encouraging foals to focus on humans rather than their mothers, optimizing the mare's reproductive efficiency, and controlling the foal's nutritional intake. However, as Henry (2020) notes, many of "these reasons are based more on habits and tradition, perhaps even on false beliefs, and clearly not on the prospects for improving the welfare of domestic foals."

Although natural weaning may not be feasible in large-scale operations readying young thoroughbreds for the fall sales, the majority of breeding situations could consider natural weaning with minor management changes (installing selective feeders so foals have access to adequate nutrition, supplying free-choice forage so that mares do not lose condition, and so on).

The benefits of natural weaning may well outweigh any potential costs to this management shift. Foals readily learn from their dams and much of the foal's education (handling, trailering, desensitization to novel objects, etc.) can be addressed with the aid of a well-seasoned and calm mother (Christensen, 2016). Natural weaning also put foals at a greatly lowered risk of developing stereotypies. Research has shown that as many of 67% of individually housed foals developed a stereotypy after abrupt weaning (Visser, 2008). Even with more natural housing arrangements, the majority of all equine stereotypies develop within one month of weaning (Nicol 1999), placing weanlings in the highest risk age group for stereotypy development. This risk factor alone should be sufficiently alarming to make breeders rethink weaning practices.

Stereotypies are typically lifelong, almost impossible to eliminate once established, detract from the animal's value and marketability, and in extreme cases may lead to such overwhelming behavioural disturbances (e.g. severe cases of equine self-mutilation syndrome,) that the only recourse is to have the horse destroyed.

Given the compelling evidence of the negative effects of artificial weaning and the clear benefits of natural weaning, I would suggest a paradigm shift to make natural weaning the default and artificial weaning the anomaly, rather than the other way around. At the very least, we should always start with the question, "Do I actually need to wean this foal right now?"
