






# U CAN DO U

Breeders Fleming Thoroughbred Farm, LLC. U CAN DO U share of the purse was \$53,495.00. He finished the six furlongs in 1:10.01.





# The Material Participation Test Can Trick Taxpayers

Often enough taxpayers who are audited in connection with their farming or livestock activities are questioned on the issue known in the tax law as the "material participation test." Under this legal test, you are permitted to deduct losses against outside salary and wages only if, among other things, you "materially participate" in the activity. Many duties, such as training of animals, showing of show horses and racing of race horses, are delegated to qualified experts, and sometimes the IRS will question the validity of your own participation in decision making, in an effort to say you have failed to meet the material participation test.

This usually happens in the context of ventures that involve a partnership or joint venture. For instance, Joseph Machado of Long Beach, California, entered into the LB Partnership with four other partners to purchase a broodmare named La Barbara. One partner was the managing partner and was responsible for maintaining the books and records of the partnership and for paying all expenses. The partnership made decisions by majority vote of all six partners. The broodmare was bred to a number of stallions, but the partnership generated losses over a period of 7 years.

The Tax Court denied Mr. Machado the right to write off these losses against his income from a trucking business he owned because it held he did not materially participate in the partnership. Accordingly, his losses were limited by the passive income rules of Section 469 of the IRS Code and could not be used to offset his non-passive income.

This case illustrates the importance of obtaining advance legal guidance whenever you enter into a partnership if you intend to write off possible losses against nonpassive income sources. The material participation test is something you must plan on meeting and complying with, and is not something to be treated lightly. As a general rule, a taxpayer will be regarded as materially participating in a partnership if he is involved in the operation of the activity on a "regular, continuous, and substantial" basis.

What does that mean? A threshold requirement for meeting this test is that the taxpayer has participated in the activity for more than 100 hours during each taxable year. A taxpayer can establish the extent of his participation by any reasonable means including "the identification of services performed over a period of time and the approximate number of hours spent performing such services during such period, based on appointment books, calendars, or narrative summaries." But in the case of Mr. Machado, the only evidence he presented at trial regarding participation in the partnership was his uncorroborated

testimony that he spent hundreds of hours researching potential stallions to breed with La Barbara, and a calendar log that reflected 15 entries for phone calls he made relating to the partnership. Even with that meager evidence, the number of hours shown was less than 100 hours per year.

The kind of activities that a taxpayer should be able to document during each year may include the following: consulting with advisers, other breeders and veterinarians, attending horse shows, horse sales, or races, seeing horses being worked, keeping business records, discussing matters with one's spouse and other partners, implementing or formulating business plans and revising them, reviewing finances, making cost projections, making disbursements, speaking with vendors on the telephone or in person, talking to potential customers, grooming horses and tending to the physical labor that is part of proper animal husbandry, and performing other tasks and decision-making functions. But it is imperative that records be kept to reflect the number of hours involved, and the number must be 100 or more hours per year.

In my opinion, the material participation test does not apply to ordinary stallion syndications, which are not partnerships in the technical sense, but instead are co-ownership entities where each owner has a fractional interest in the stallion. Still, the IRS has been known to challenge taxpayers on the material participation test in these contexts. I think part of the reason is that some revenue agents are confused as to the application of this provision of tax law.

It is important to keep in mind that the material participation test is supplemental to the overall IRS Regulations concerning the objective intention to make a profit. Even if you can prove material participation in a horse activity, the IRS could still find the venture was merely a hobby by arguing that you do not have the overall intention to be engaged in a trade or business for profit or that there are other elements, such as recreation, lack of reliance on experts, or insufficient showing of the amount of time expended in the venture—-to satisfy IRS Regulations on the subject.

U Can Do U, away alertly, disputed the pace four wide under rating and jockey Glenn Corbett moved to the inside of a rival, held a slim lead past the three eights, responded when asked nearing the lane and repelled an inside threat, spurted clear then held firm while ridden out. DON JUAN BUBBA broke outward and bumped with MARVELOUS MARK, corrected and edged up between foes, moved through towards the rail and challenged approaching the stretch, drifted a bit when not quite quickening with the winner, corredted and stayed on well to be second best. BIYOMBO vied five wide outside the winner, failed to go on with the leading past nearing mid stretch and faded. MAR-VELOUS MARK, bumped at the break, raced well wide and faded. HATAGASAL broke awkwardly faltered early then was taken wide and was eased through the final quarter mile.

# Common Equine Dental Problems and How To Avoid Them



# Open wide! Let me see those teeth.

As herbivores, horses are grazing animals. Before humans domesticated and confined horses, they grazed nearly 16-18 hours per day. Positioned with their heads down, snipping blades of grass and chewing in a circular motion, a horse's chewing action naturally wears teeth evenly.

Routine dental checks and basic care, such as floatings, can help you avoid costly and painful dental surgery for your horse.

Most horses today do not have the opportunity to graze for hours at a time, thus leading to increased opportunities for dental problems. Limited access to grass, combined with rations of grain and hay fed at regulated intervals and hay fed from elevated racks or nets, contribute to changing the angle at which a horse chews and consequently altering the wear patterns on horse's teeth.

From the time a foal is born, the horse's teeth are constantly changing. Teeth are continually erupting and maturing. Because a horse's teeth change frequently from birth to age five and again as they age, it is important to identify if dental issues develop in between scheduled check-ups.

Dental problems not only cause discomfort in your horse's mouth, but can also affect a horse's movement and musculoskeletal structures of the neck and back, causing pain, stiffness, and inflammation. A combination of physical and behavioral changes can suggest an issue with your horse's teeth.

# Physical Changes

- 1. A change in the smell of your horse's breath from its mouth and nostrils
- 2. A change in the color of your horse's gums
- 3. A change in daily eating habits, including eating hay before grain, dunking hay in water, or larger than normal feed particles in the manure
- 4. A dribbling of feed or drooling
- 5. Sores on the lips, gums, palate, or soft tissue
- 6. Discharge from the eyes or nose

# Behavioral Changes While Riding or Handling

- 1. Head tossing
- 2. Tilting of the head
- 3. Difficulty bridling
- 4. Rearing
- 5. Grabbing the bit/lack of control

Regular dental check-ups with an equine dentist or veterinarian can identify and even correct uneven dental wear. The list of dental abnormalities is a long one. Some of the most common dental problems are listed below.

Excessive Transverse Ridges: Teeth with excessive transverse ridges look like an old-fashioned washboard. While it is normal and desirable for teeth to have ridges, if the ridges become too pronounced they can affect the movement of the mandible and temporal mandible joint. Routine dental procedures can smooth out the extreme ridges.

# **BEYOND AWESOME**

## Cactus Flower Stakes




Owner: Jeremy Ramsland Trainer: Justin Evans Breeder: Triple AAA Ranch BEYOND AWESOME set the pace facing moderate outside pressure, met the challenge of the runner-up coming to the quarter pole, drifted out eight wide leaving the turn, drifted out a bit further in mid stretch, held that rival under steady urging by jockey Corbett. OUTSIDE THE LAW pursued the leader pair from outside, advanced on the turn making a mild bid past the five-sixteenths, was carried nine wide by the drifting leader leaving the turn, kept on gamely in the stretch but was second best. UNRI-VALED QUEEN was ridden along at the back, swung ten wide turning for home, improving position. BANGIE GO chased from outside a rival, angled five to six wide in the stretch and failed to menace. LOTSA LACE chased from inside, and was not a threat. BOLD INTENTION pressed the eventual winner from outside four to five wide into the turn, came up entry.

There was an objection by the trainer of OUTSIDE THE LAW AGAINST BEYOND AWESOME Alleging interference. No Action was taken.

Dental hooks occur on the upper front molars in horses that feed principally on hay or lush pastures. An equine dentist would file the point to the red line.

#### Hooks:

Hooks develop from a misalignment of the molar arcades, commonly caused by an overbite (parrot mouth) or under bite (sow mouth). All herbivores require tooth opposition to wear teeth evenly. The portion of the tooth that is not in contact with an opposing tooth will become longer, causing extreme discomfort. Left unattended, hooks can even lead to weight loss, choke, and potentially colic.

Incisor Dental Conditions: Incisor dental conditions are caused by a variety of situations, including retained deciduous teeth, traumatic injuries, and even vices like cribbing or wind sucking, and inherited abnormalities. Emergency situations like a kick to the face are treated on a case-by-case basis. Uneven wear from vices can be corrected by a veterinarian or equine dentist and by altering the horse's environment to limit cribbing and wind sucking.

Horses with Parrot Mouth are more likely to require dental procedures to remove hooks, and improve chewing.

#### Parrot Mouth:

A horse with a parrot mouth has upper incisors that protrude or hang over the lower incisors. Horses with a parrot mouth also tend to have large upper hooks and large lower hooks on the molar arcades. According to Shelley Lavigne, Ed, owner of Equine Dental of Central CT. "In most cases, a procedure known as incisor reduction and corrective floating is performed to restore anterior-posterior movement of the jaw and to reduce pressure that this exerts on the Tempromandibular joint."


## Ramps:

Ramps are similar to hooks, but more gradual in slope. Ramps on the lower cheek teeth can cause pinching of the soft tissue and will limit the movement of the mandible. Sharp Enamel Points: According to Lavigne, "Nearly all horses develop sharp enamel points on the outside of the upper cheek teeth and on the inside of the lower cheek teeth over time as the horse's teeth erupt." Regular dental checkups and routine care can eliminate sharp points on teeth.

Shear Mouth: Rather than chewing food in a circular motion, a horse suffering from a shear mouth chew up and down rather than side-to-side. The outer edges of the cheek teeth develop long sharp edges. According to Lavigne, "A horse with shear mouth will have difficulty maintaining a healthy body weight and if left unattended, it can be life threatening. Fortunately, this is a rare dental condition, but frequent, small adjustments can allow the horse to chew normally over time."

#### Wave Mouth:

Wave mouth describes uneven wear of the molar arcades that create an effect that looks like a roller coaster. Horses with a wave mouth are unable to grind food. Frequent dental care and potentially changes to the horse's diet are necessary to maintain the horse's nutritional health.



Wolf Teeth: Wolf teeth can often interfere with the bit and are often removed. In horses under three years old, wolf teeth can easily be completely removed. Extracting wolf teeth in older horses can become problematic as the teeth become firmly attached to the bone below.

This conditions occurs when an opposing tooth is broken. The unopposed tooth continues to grow into the unoccupied space causing difficulties in chewing.

Other Dental Problems: In addition to abnormal wear and congenital deformities, common dental problems include abscesses, fractured teeth, periodontal disease, and others. An Equine Dentist or Veterinarian can examine, diagnose, and provide treatment based on each specific circumstance.

Routine dental care by an educated Equine Dentist will help your horse to be more comfortable, utilize feed more efficiently, be happier under saddle, and live longer.





All yearlings that are consigned and pass through the sale ring become eligible for the A.T.B.A. Fall Sales Futurity & Fall Sales Stakes (Fall Sales Futurity- \$50,000 bonus paid to an Arizona-bred winner for each divison, Fall Sales Stakes - \$12,500 bonus paid to an Arizona-bred winner in each divison)

Should either division (fillies or colts) fail to fill (five or less), the two divisions may be combined into one race. All entrants to trials or race must pay \$500 to enter. All entrants must pass the entry box for the trials and finals at the usual time of closing for that racing day. Weights for the Futurity trials and finals: Fillies, 120 lbs.; Colts/Gelding 122 lbs.

Derby for three-year-olds. Starters shall not exceed twelve. To start in the Derby all entrants must pay \$300 to pass the entry box by the usual time of closing for the Derby. In the event there are more than twelve at the time of entry, the starters shall be determined at that time with preference given to those entries that have accumulated the highest earnings, with winners preferred regardless of earnings. Entries not drawn into the body of the race will be placed on an also-eligible list in order of preference. In the event of a scratch in the body of the race prior to the official scratch time, entries on the also-eligible list will be moved into the body of the race based upon their order of preference. In the event that two horses have the same amount of earning position on the also-eligible they will be determined by lot. Any nominee excluded from running as a result of the aforementioned preference rule shall have the entry fee refunded. Weights: Fillies 120 lbs. Colts/Gelding 124 lbs.

#### **☞** JOANNE DYE BREEDERS' OAKS - One Race - Fillies • NO TRIALS

Oaks for three-year-olds fillies. Starters shall not exceed twelve. To start in the Oaks all entrants must pay \$300 to pass the entry box by the usual time of closing for the Oaks. In the event there are more than twelve at the time of entry, the starters shall be determined at that time with preference given to those entries that have accumulated the highest earnings, with winners preferred regardless of earnings. Entries not drawn into the body of the race will be placed on an also-eligible list in order of preference. In the event of a scratch in the body of the race prior to the official scratch time, entries on the also-eligible list will be moved into the body of the race based upon their order of preference. In the event that two horses have the same amount of earning position on the also-eligible they will be determined by lot. Any nominee excluded from running as a result of the aforementioned preference rule shall have the entry fee refunded. Weights: Fillies 122 lbs.

#### ALL RACES WILL BE RUN UNDER THE FOLLOWING RULES.

All races will be restricted to 2023 Arizona-bred foals, registered and certified by the Arizona Thoroughbred Breeders Association. To be eligible to start in the Futurities or the Derby/Oaks foals must be registered and certified by February 1, 2025. The ATBA will deduct ten percent of all nominating and sustaining payments for clerical fees before each race. The balance to be divided as follows: Original and sustaining payments to be split 50% to the Futurities and 50% to the Derby/Oaks. (Futurities and Derby/Oaks monies to be split % by gender). Monies will be divided: 50% to winner, 20% to second, 10% to third; 5% to fourth; 3% to fifth; 2% to sixth; (in the futurity 1% to the next six finishers) (in the derby/Oaks 1% to each of the next six finishers) and 4% to be paid to the nominator of the winner of each race. To remain eligible for the Derby/Oaks, horses do not have to start in the Futurities, however all sustaining payments must be made through October 15, 2026. To remain eligible for the Derby/Oaks an additional \$300.00 is due January 15, 2027.
